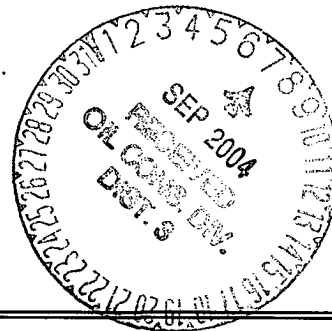

Pumped 4 bbls H2O, dumped 50 sx (81 cf - 14.5 bbl slurry) Type 1-2 Portland cement w/20% Flyash. Dropped plug and displaced w/6.6 bbls H2O. Circ. 1 bbl cement to surface. WOC. Installed WH. RD & released rig.

The casing PT will be conducted by the drill rig before drilling continues.
