7/27/04 TOH w/rods, pump and tubing. TIH w/casing scrapper to 4680'.
7/28/04 Set 4-1/2" RBP below Fruitland Coal perfs at 4388'. TIH & set pkr @ 4380'. Test RBP to 2500 psi - held OK. Dump sand on top of plug.
7/29/04 Squeeze Fruitland Coal perfs w/100 sx cement.
8/3-4/04 Drill out cement and pressure test squeeze to 1000 psi-held OK.
8/5-6/04 TIH w/tbg & packer. Acidize Lower PC w/1000 gals 15% HCL. Set pkr above top PC perf and acidize Upper PC w/1000 gals 15% HCL.
8/9/04 Ran 2-3/8" tbg, landed at 4675'. Rod up well. Return to prod. — Test.
