State No. 7 1650' FSL & 330' FWL, Section 16, T16N, R6W McKinley County, NM

6/3/2003: Rig up JC Well Service. Trip out with rods and pump. Trip in tubing and tag PBD at 1216'. Roll hole with water. Mix and spot 16 sack bottom plug at 1216'. Trip out tubing and WOC.

6/4/2003: Trip in and tag plug at 1060'. Pressure test casing to 200 PSI, failed. Perforate squeeze holes at 131'. Mix and pump 64 sacks cement. Circulated cement up casing and up backside. Rigged down. Class B cement was used.

Top off cement in both casings. Installed abandonment marker and backfilled pit. Cleaned up location.
