Drilled 12-1/4" hole to 305'. On 8/25/04, set 6 jts 9-5/8" 32.3# casing at 298'. Cemented with 175 sx (36 bbls) "B" cement w/ 2% CaCl2 and 1/4# Flocele. Circulated 10 bbls cement to surface. Pressure tested casing to 1500 psi.

Drilled 8-3/4" hole to 2878'. On 8/28/04, set 66 jts 7" 23# casing at 2872'. Cemented with 525 sx (137 bbls) 50/50 Poz w/ 3% Gel, 0.1% CFR-3, 0.2% Halad 344, 5# Gilsonite, and 1/4# Flocele. Tailed in w/ 75 sx (16 bbls) "B" neat. Circulated 10 bbls to surface. Pressure tested casing to 1500 psi.

Drilled 6-1/4" hole to 3340'. Underreamed hole to 9-1/2" from 2878' to 3340'. Utilized natural and air assisted surges to remove near wellbore material. No casing was run or cement pumped in this section of hole. Landed 2-3/8" production in openhole at 3106'. If well conditions dictate at a later date we will install a 5-1/2" liner in well.
