Drilled 12-1/4" hole to 305'. On 8/17/04, set 6 jts 9-5/8" 32.3# casing at 293'. Cemented with 175 sx (36 bbls) "B" cement w/ 2% CaCl2 and 1/4# Flocele. Circulated 9 bbls cement to surface. Pressure tested casing to 1500 psi.

Drilled 8-3/4" hole to 3248'. On 8/21/04, set 63 jts 7" 23# casing at 2967'. Cemented with 500 sx (131 bbls) 50/50 Poz w/ 3% Gel, 0.1% CFR-3, 0.2% Halad 344, 5# Gilsonite, and 1/4# Flocele. Tailed in w/ 75 sx (16 bbls) "B" neat. Circulated 10 bbls to surface. Pressure tested casing to 1500 psi.

Drilled 6-1/4" hole to 3471'. Underreamed hole to 9-1/2" from 2990' to 3400'. Utilized natural and air assisted surges to remove near wellbore material. No casing was run or cement pumped in this section of hole. Landed 2-3/8" production in openhole at 3395'. If well conditions dictate at a later date we will install a 5-1/2" liner in well.
