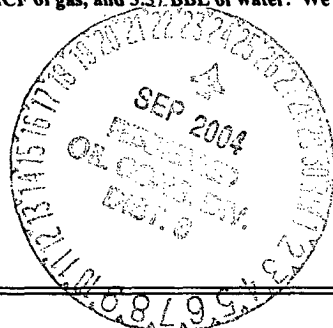
Production from this well has not reached the original anticipated volume, which we believe is in part due to the original fracture treatment.

On 9/8/04 we re-fraced existing perforatations 2203'-2301' with 88,600 gal 70Q N2 Lightning 20#, and 175,420# 20/40 Brady Sand.

On 9/12/04 we tested the refraced coal zone for 8 hours, and the results were 216 MCF of gas, and 3.57 BBL of water. We believe we have increased the production in this well.

On 9/13/04 we landed the 2 3/8", 4.7#, J-55 tubing @ 2290.77'.

This well was returned to production on 9/14/04.
