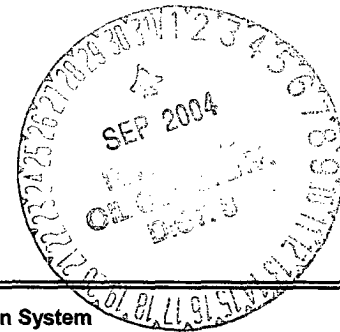
This well was down-hole commingled as follows:

6/30/04 Clean out to PBTD. Ran 2-3/8" tbg, landed at 3566'. Return well to production.
