Pumped preflush of 20 bbls then pumped Lead - 11 sx (28 cf - 5 bbl slurry) Scavenger Type III w/3% CaCl₂, .25#/sx Celloflake. Pumped tail w/162 sx (208 cf - 37 bbl slurry) Type III cement w/3% CaCl₂, .25#/sx Celloflake. Dropped plug and displaced w/15.8 bbls water. Plug down @ 0158 hrs 9/1/04. Circ. 15 bbls cement to surface. RD BJ. WOC. NU BOP. PT blind rams, casing and outer manifold valves to 600 psi/30 minutes. Good test.
