Pumped 4 bbls H2O, dumped 50 sx (81 cu ft 14.5 bbl slurry) Type 1-2 Portland Cement w/20% Fly Ash. Dropped plug and displaced w/6.6 bbls H2O. Circ 1.5 bbls to surface. WOC. Installed WH. RD & released rig.
