It is intended to restimulate the Pictured Cliffs formation in the subject well as follows:

Move in, rig up. Pull tubing. Deepen the well to approximately 2526'. Run 2 7/8" 6.4# J-55 EUE csg to total depth. Cement 2 7/8" casing with 130 sx cement (yield of 2.13 cu.ft. per sack, 12.10 ppg). Tail w/35 sx cement (yield of 1.47 cu.ft. per sack, 14.20 ppg). Fracture stimulate the Pictured Cliffs formation. Return well to production.
