We would like to plug this well as follows:

Bullhead water into the well to ensure that the well will take water and that none comes out the braden head. If both conditions are met, then we will bullhead cement from the btm perms to aprox. 591' from surface. We will then tag cement with wireline, and then perf. At 88' (83' from surface) and circulate cement from 83' to surface in 7" surface casing. We will then top off with cement and install a dry hole marker.
