Spotted 150 sx (177 cu.ft.) of CI "B" cement with 1/4#/sk celloflake across the Menefee and Cliff House formation WOC overnight. Tagged cement top at 1596' KB. TOH with the drill pipe. Ran 5-1/2", 15.0%#, LS casing and set at 1267' KB. Cemented with 140 sx (288 cu.ft.) of CI "B" with 2% SMS and 1/4#/sk celloflake. Tailed with 110 sx (130 cu.ft.) of CI "B" with 5#/sk. gilsonite and 1/4#/sk celloflake. Total cement volume was 418 cu.ft. Circulated full returns throughout the job and circulated out water with cello flake but did not circulate cement. Bumped plug to 1500 psi - float held. Hole is staying full. SI well. Waiting on completion.
