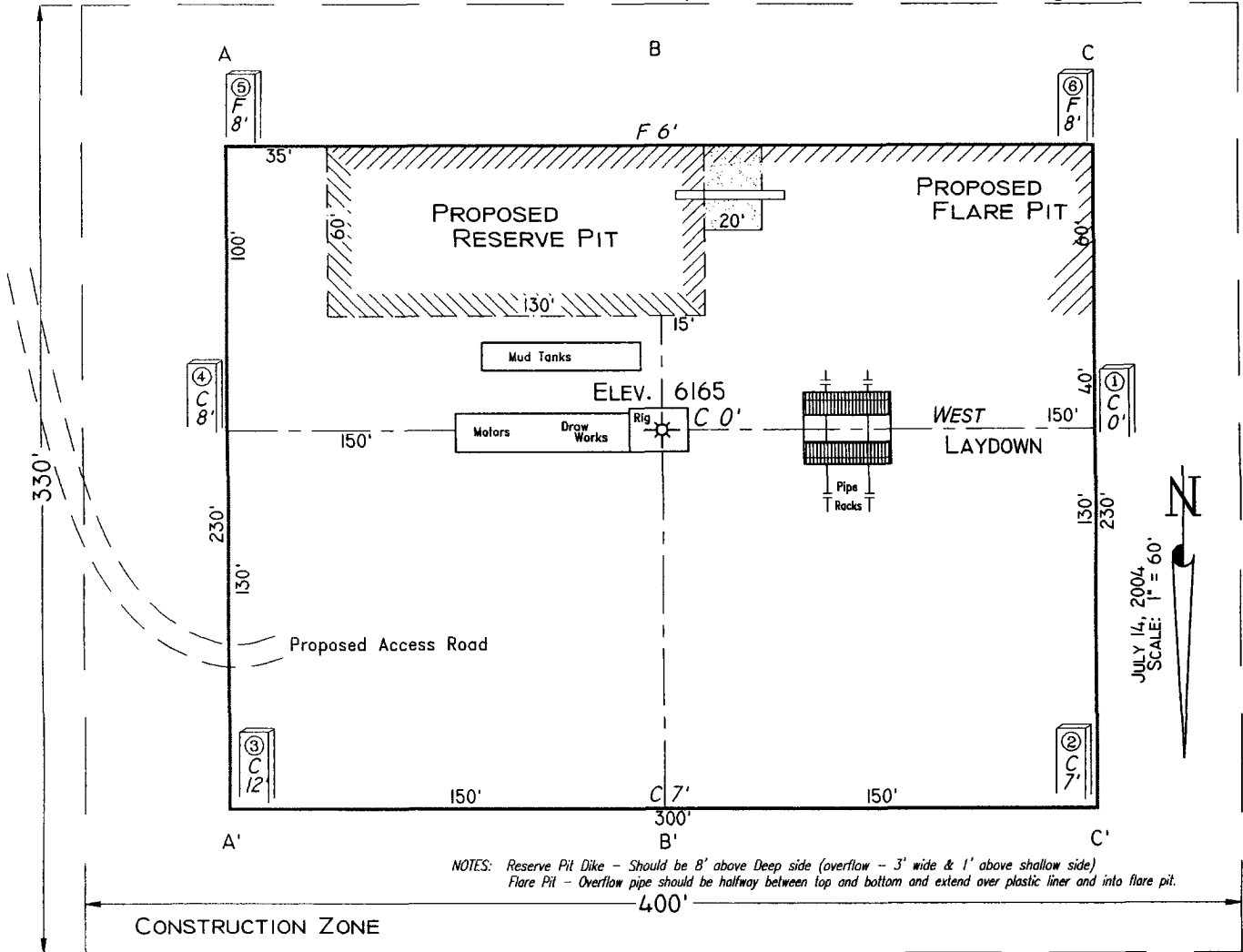

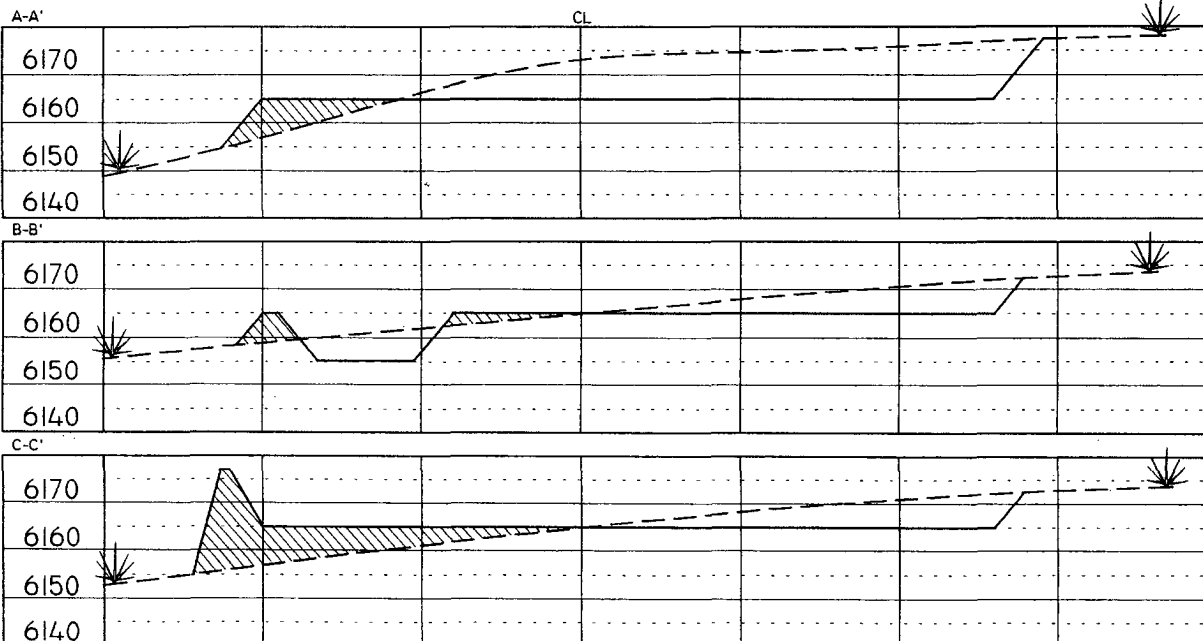
PAD LAYOUT PLAN & PROFILE
