

Burlington Resources anticipates closing the pit according to the Drilling / Workover Pit Closure Procedure dated August 2, 2004 on file at the NMOCDD office.

On this well, a blow/flare pit may be the only pit that will be required. A portion of this blow/flare pit will be designed to manage fluids, and that portion will be unlined, as per the risk ranking criteria.


