Pull 1" tbg. Set 5-1/2" BP @ 1550'. Perf 5-1/2" csg @ 1512' & attempt to circ. cmt out bradenhead. Drill & CO to new TD 2350'. Run CNL log. Land 3-1/2" 9.3# K-55 csg @ 2350' & cmt (288 cf) to surface. Perf PC @ ~2198'-2276' & frac w/110,000# sand in 70Q foam. Clean out to PBTD. Run 1-1/4" tbg & complete as a single PC gas well.
