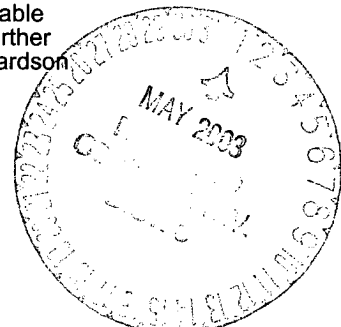

The top of cement in this well has been determined to be no lower than 65'. There is cement response to this point on the CBL ran on 4/11/03. The fluid level was 65', so no data is available above this point. The transition from lead to tail cement is noted at 600' on the CBL which further supports that cement has reached surface casing based on cement volumes pumped. Richardson Operating Company does not plan any remedial cement work on this well.

CBL logs will be delivered to the Farmington BLM office by 4/24/03.
