Drilled 12 1/4" hole to 305' on 11/16/04, set 6 jts of 9 5/8", H-40, ST&C, 32.3# casing at 295'. Cemented w/175 sx (37 bbls) "B" cement w/2% CaC1 and 1/4# PSX Floseal. Circulated 10 bbls of cement to surface. Test casing to 1500 psi.

Drilled 8 3/4" hole to 3,440' on 11/19/04, set 77 jts of 7", J-55, LT&C, 23# casing at 3,435'. Cemented lead w/500 sx (129 bbls) 50/50 POZ w/2% Gel, 0.2% Versaset, 0.1% Diacel LWL and tail w/75 sx (19 bbls) 50/50 POZ w/2% Gel, 0.2% Versaset, 0.1% Diacel LWL. Circulated 30 bbls of cement to surface. Tested casing to 1500 psi.

Drilled 6 1/4" hole to 7,825' on 11/22/04, set 171 jts 4 1/2", J-55, LT&C, 11.6# casing at 7,821'. Cemented lead w/250 sx (65 bbls) 50/50 POZ w/2% Gel, 2/10% Versaset, 1/10% Diacel LWL and tail w/450 sx (118 bbls) 50/50 POZ, 3% Gel, 1.4% Halad 9, 1/10% CGR3-5, 5# Gilsontite & 1/4# Flocele. No cement to surface, TOC @ 1,350'. Landed 2 3/8" production tubing at 7,753'.
