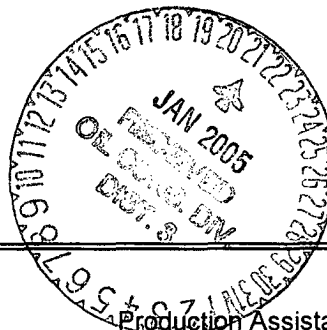

Elm Ridge Resources, Inc. has spud the above referenced well as of 12-10-04. We drilled a 12 1/4" hole to 257'. Ran 8 5/8" 24# J-55 casing to 259'. Pumped 185 sks of standard cement. We didn't get cement to surface on 1st try. We did a top set with 1" pipe and pumped another 50 sks of cement. We circulated 1.5 bbls to excess to surface. Pre tested well to 1500 PSI.
