Cemented 1st stage w/230 sx (301 cf) 50/50 POZ w/2% gel, 5#/sx gilsonite & 1/4#/sx flocele, mixed @ 13.5 ppg & yeild = 1.31 cf/sx. Inflate ECP @ 939' & open DV tool @ 937'. Circ. 10 bbls cmt from DV Tool. Cemented 2nd stage w/615 sx (1190 cf) 50/50 POZ w/6% gel, 5#/sx gilsonite & 1/4#/sx flocele, mixed at 12.5 ppg & yeild = 1.83 cf/sx. Tail w/ 50 sx (61 cf) standard w/5#/sx gilsonite & 1/4#/sx flocele, mixed @ 15.4 ppg & yeild = 1.22 cf/sx. Circ. 40 bbls good cmt to surface.
