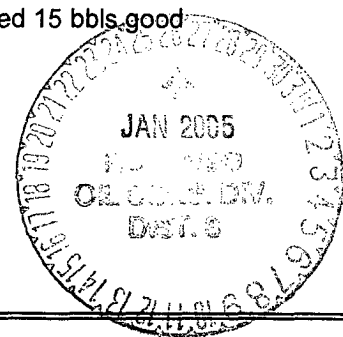

Elm Ridge Resources, Inc. has spud the above referenced well as of 12-17-04. We drilled a 12 1/4" hole to 260'. Ran 8 5/8" 24# J-55 casing to 259'. Pumped 250 sks of standard cement. We circulated 15 bbls good cement to surface. Pressure test well to 1500 PSI.
