

Water production on this well has dropped off. On 12/2/04 we pulled rods and downhole pump.

On 12/3-12/4/04 we cleaned out the wellbore to prep for 2 1/16" tubing.

On 12/4/04 we ran 2 1/16" tubing, landed @ 2159.60. The 2 1/16" tubing did not allow for fluid lift as anticipated.

On 12/6/04 we pulled 2 1/6" tubing, and ran 1 1/2", 1.900" OD, J-55, 2.9# tubing, landed @ 2171.02'. We returned the well to production. We have seen a slight increase in production, and the ability to lift water with the smaller tubing.
