BP America Production Company respectfully requests an administrative approval for a non-standard well location for the Florance R Well No. 8C to be drilled at a location of 2065' FSL and 1670' FWL of Section 14, T30N-R09W. The non-standard location is necessitated by topographical conditions - steep terrain, archeological concerns and an existing pipeline - and would insure the conservation of surface and subsurface resources in the area.

To aid in your review attached is a C-102, Well Location Plat, indicating the proposed well location and the existing Mesaverde wells in the BP operated 320 acre unit in the S/2. BP has a 100% working interest in the offsetting 320 acre unit in the N/2 of section 14. Also attached are a topographical map and a 9-section plat showing the offset wells.

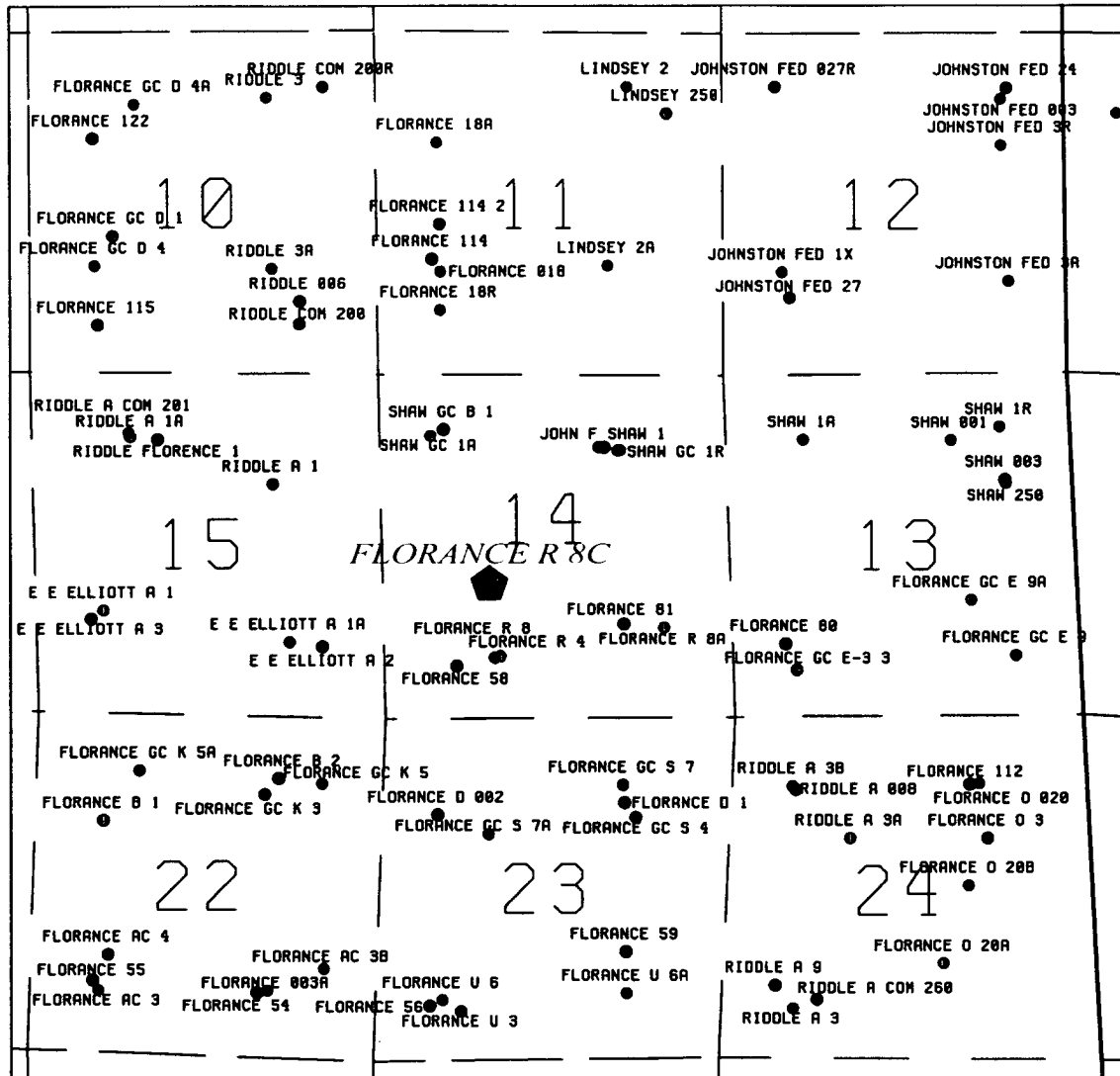

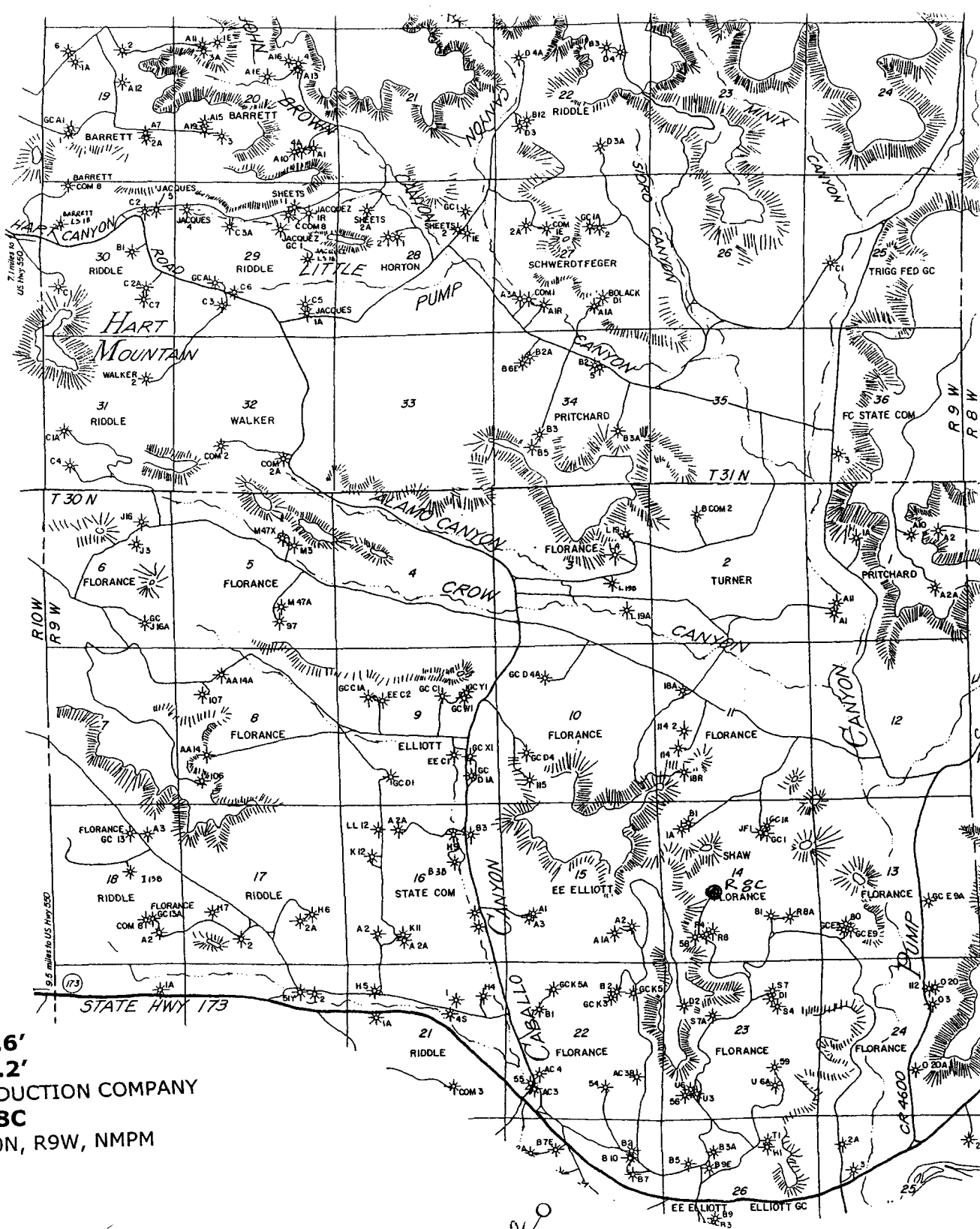
