Pumped preflush of 2bbls H2O, then pumped 34 sx (54 cf- 9.6 bbls slurry) Type 1-2 Portland cement w/ 20% flyash & 14.5 ppg into casing. Dropped plug and displaced with 3.6 bbls H2O. Circ. 1 bbls to surface. WOC. RD & released rig.
