



1/25/05 MIRU Aztec #471. 1/26/05 Load hole & PT blind rams and casing to 1500 psi/30 min. OK. RIH w/6-1/4" bit & tagged cement @ 3121'. D/O cement & then drilled ahead to 3580' (TD). TD reached 1/28/05. Circ. hole. RIH w/9-1/2" underreamer. Underreamed 6-1/4" hole to 9-1/2" from 3181' - 3580'. Circ. hole. Began natural surges 2/1/05. Surged well naturally and with air/mist & foamer for approx. 7 days. RIH w/mill & COUT to 3465'. COOH w/mill. C/O fill w/surges again for 4 days. Used mill to C/O to TD. Used air & mist to COUT to 3578'. TOH. PU & ran 5-1/2" 15.5#, J-55 pre-perf'd liner & set @ 3578' w/TOL @ 3148' (7" shoe @ 3176' = 28' overlap). Perf are between 3236' & 3410'; 3453' - 3496' @ 2 spf .5" holes. = approx. 216' = 432 holes. TIH w/mill & milled perf plugs. TOH. RIH w/2-3/8", 4.7# J-55 tbg and landed @ 3489' w/SN @ 3469'. ND/NU. 4/22/05 RIH w/pump & rods. PT pump & rods. Spaced out. ND WH & NU BOP. RD & released rig 2/24/05.
