Proposed perforations are: PC - 3394' - 3594' ; FC - 3012' - 3393' These perforations are in TVD.

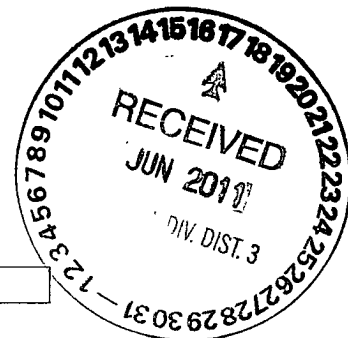
As referenced in Order # R- 10696 interest owners were not re-notified.
