3/14/11 - TIH and set Composite BP @ 3850'. Load hole w/2% KCL. Pressure test casing. Failed.

3/15/11 - TIH with packer. Casing failure found between 3484'-3706'.

3/16/11 - Pumped 50sks TypeIII Cement(1.44yield, 14.3ppg) followed by 150 sks class "G" cement(1.15yield, 15.8ppg).

3/17-3/18/11 - Drill out cement. Pressure Tested Casing to 550psi. Failed.

3/21/11 - Round trip 4-1/2" scraper.

3/22/11 - Isolate leaks with packer. Leaking between 3484'-3670'.

3/23/11 - Pump 325sks Class "G" w/ 1% CACL2 followed by 25sks Class "G" w/ 2% CACL2.

3/24-3/25/11 - Drill out cement. Pressure Tested Casing to 500psi. Failed.

3/28/11 - Set Cement retainer @ 3230'. Pumped 195sks of 50/50 "G"/POZ w/ 1% bentonite, 0.02% Halad-334, 0.03% Versaset and 2% CACL2.

3/30-3/31/11 - Drill out cement. Pressure Test to 500psi. After 30 mins, pressure held at 472psi. Pressure Test Good.

4/1/11 - Drill out BP. Tagged 4' of fill @ 5935'. TIH w/ 181jts 2-3/8" tubing. SN @ 5717'. EOT @ 5749'.

4/2/11 - NDBOP. NUWH. RDMO.
