5/2/11 MIRU Maverick Coiled tubing unit. RU CT unit. PT lines & Test BOPS. Open Master valve & spool in CT. Pumped 2% KCL - 33 bbls. Unload hole w/600 scf N2. CT on bottom, pumped 41 bbls 12% Formic acid & 85,000 scf N2. Flushed w/2% KCl water. Spool out of hole w/CT. Well stopped flowing. 5/3/11. Spooled back in hole and unloaded fluids from well w/N2. RD Injector head & RD N2 Unit & CT unit. Released Maverick on 5/3/11.

Since this procedure didn't improve production, this well will be P&A'd. Engineering group will work up a procedure to P&A and it will be submitted soon. Plans are to have this well P&A'd within 60 days.
