Pre-flush w/ 10 bbls pre-flush and 20 bbls spacer. Pumped 76 sx (122cf-22bbl=1.60 yld) Premix cmt w/ 20% fly-ash. Drop plug & displaced w/ 15 bbl FW. Bump plug @ 300#. No cmt to surface. RD RR @ 18:30 hrs on 6/17/11. 6/18/11 Top set by pumping 24 sx (33cf-6bbl=1.39 yld) Neat cmt. Circ 3/4 bbl cmt to surface. 6/20/11 NU WH.
