5/17/2011 - Ran RBP @ 6491'. Set packer @ 6459'. Tested tubing to 1000 psi - held ok. Tested casing to 2000 psi - held ok. Retrieved packer and RBP.

5/18/2011 - Started Basin Dakota frac. Well head assembly failed. Shut down frac equipment. Killed well. Secured well head. Repaired top 41" of bad surface casing. Installed new 8-5/8" 2000 psi independent wellhead and 4-1/2" 3000 psi independent wellhead.

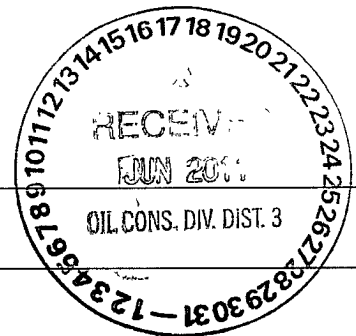
5/20/2011 - Ran RBP @ 6470'. Tested casing to 1000 psi for 15 minutes and was charted by High Tech - held ok. Retrieve RBP and POOH. Frac Basin Dakota w/32,345# 20/40 sand @ 3457 psi. PU and ran 211 jts 2-3/8" 4.7 #/ft J-55 tbg set at 6591'. Ran 1-1/4" RHBC pump on 3/4" Class D rods.

6/1/2011 - Turned well over to production.
