Cement with 140 sks Type V, 2% CaCl2 with 1/8#/sk floccale (168 cu.ft.). Circulate 8 bbls cement to surface. Bump plug @ 7:45 am on 06/27/11. WOC. RD Halliburton. NU BOP. Test casing with 750# for 30 minutes - ok. Test BOP to 250# low - 15 minutes and to 3000# high - 15 minutes ok.
