The subject well was recompleted into the Mesaverde formation in November 2010 with a CIBP set @ 8511' covering the Dakota interval due to winter closure the work was not completed on the well. 6/30/2011 Notified BLM (Stephen Mason) & OCD (Brandon Powell) of plans to isolate the wet cliffhouse and squeeze the existing perms then drill out the CIBP set @ 8511' and isolate the Dakota water. If the Dakota water cannot be isolated the Dakota zone will be plugged back. Verbal approval was received 6/30/11.
