The drilling rig on the subject well pumped the cement job of the Intermediate casing and was unable to pressure test. Intermediate shoe @ 4927' (TVD) with stage tool @ 3504' (TVD) and pumped the 1st and 2nd stages of cement with no problems and 30bbls cement returns on both stages. Attempted to PT to 1500# and leaked down to 300#. RIH w/ pkr and isolated leak around stage tool from 3740' - 3706' (MD). Notified BLM (Troy Salyers) & OCD (Charlie Perrin) on 7/21/11 and requested permission to set balance plug from 3600' - 3400' (TVD) with 10bbls of Type III cement. WOC. Drill out and PT to 600#/30min. Verbal approval was received 7/21/11.
