Burlington Resources is requesting to modify the below-grade tank permit for the SAN JUAN 28-6 UNIT 459 to correct an administrative error.

Burlington Resources found that the SAN JUAN 28-6 UNIT 459 shares a Below Grade Tank with the SAN JUAN 28-6 UNIT 142N and SAN JUAN 28-6 UNIT 125N and requests to modify the permit for the twinned location and the latitude and longitude of the existing permit.
