



Burlington Resources is requesting to modify the below-grade tank permit for the SAN JUAN 28-6 UNIT 148N to correct an administrative error.

Burlington Resources found that the SAN JUAN 28-6 UNIT 148N shares a Below Grade Tank with the SAN JUAN 28-6 UNIT 437 and requests to modify the permit for the twinned location and the latitude and longitude of the existing permit.
