6-6-2011- RIH with WS, tag bottom plug at 1208.41'. Pull WS. Mix and pump 46 Sks @ 14.8 ppg, pump down surface annulus, Shut-In.

6-7-2011- Pump down annulus, locked up at 1500 psi. RIH with WS inside 5 1/2" casing to 654.47', mix 78 Sks @ 14.9 ppg. Pump cement to top, cement stabilized.

Plan to cut off casing and place P&A Marker, clean location in next few days.
