10-02-09- RIH with 2 3/8" WS to 1583.00. Pump 45 bbls, fresh water, mix and pump 56 Sks portland @ 15.1 ppg to place bottom plug.

6-3-2011- RIH with WS, tag bottom plug at 1085'. Pull WS. Mix and pump 46 Sks @ 14.8 ppg for outside plug. Could not bullhead cement down annulus. Pump down to 500 psi. RIH with 19 jts of WS to 570' inside casing, pump cement. Pull WS, mix 35 sks @ 14.9 ppg, pump down 5 1/2" casing to squeeze for outside plug. Pump locked up at 1000 psi, Shut-In. Return next day, top off cement to surface on casing and surface annulus.

Plan to cut off casing and place P&A Marker, clean location in next few days.
