7-15-11- RIH with WS to 1213.56', tag bottom plug. Pull WS to 648' for inside and outside plug. Mix and Pump 45 Sks @ 14.6 PPG. Pull 10 Jts, WS, Mix and Pump 40 Sks @ 14.8 PPG, pump cement to top. SD.

7-18-11- RIH with WS, Tag plug at 40'. Mix and Pump 24 Sks @ 14.8 PPG. Cement to top. Cut off casing, Place P&A Marker. Clean Location.
