Proposed perforations are: MV - 3818' - 6328' ; DK - 7970' - 8218' These perforations are in TVD.

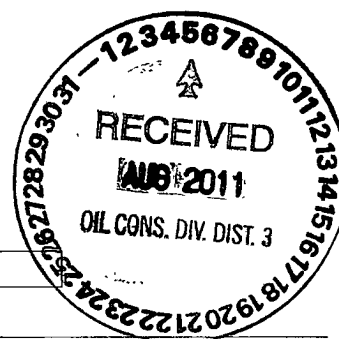
