Elm Ridge Exploration Co LLC preformed a Mechanical Integrity Test on June 6, 2011 as follows: June 3, 2011: MIRU, Open casing, SICP 450 PSI, TOH with TBG, pick up plug and packer assembly, TIH set RBP at 5733' roll hole to remove all gas, set packer at 5675' packer not holding, rig up test unit and perform MIT at 560 PSI, Paul Wiebe with NMOCD witnessed test, test passed. Released packer TIH and latch onto RBP, release plug and TOH, lay down BHA. TIH with saw tooth collar, 1 joint of 2 3/8" TBG, SN, 179 joints of 2 3/8" TBG, EOT at 5680' KB, SN at 5648' KB. We are currently waiting on a pipeline and will at that point return this well to production.

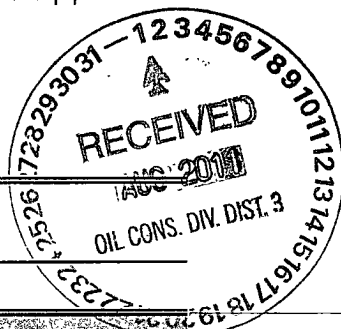
