7/29/11 Completion rig moved onto location. Pressure test valve and casing to 3500 psi for 30 minutes-ok. Two stage perforation job. First stage - Perforate Fruitland Coal from 1530'-1538' (4 SPF, 32 holes), 1484'-1488' (2 SPF, 8 holes) 1457'-1459' (2 SPF, 4 holes). Frac the with 77,502 gals of x/link gel, 70Q foam, 5000# 100 mesh followed by 111,700# of 20/40 sand. RIH with 5.50" composite frac plug. Set plug at 1430'. Second stage - Perforate Upper Fruitland Coal from 1402'-1403' (4 SPF, 4 holes), 1397'-1399' (4 SPF, 8 holes), 1393'-1395' (4 SPF, 8 holes), 1371'-1373' (2 SPF, 4 holes), 1320'-1322' (2 SPF, 4 holes). Frac with 60,127 gals of x/link gel, 70Q foam, 5000# 100 mesh followed by 104,100# of 20/40 sand. Flow back until dead. Drill out composite frac plug. Clean out with air mist and flow back.

8/10/11 TIH with 2.375", 4.7#, J-55 production tubing, set at 1590'.
