Good Morning Cory & Jonathan –

Under the 2008 Pit Rule, thousands of BGT permits were submitted by the previous operator. It is known that there were clerical errors made and some locations were permitted to have a BGT when they in deed did not have a BGT onsite. It is also known that some locations were not permitted to have a BGT and indeed do have BGT's. We remedy these when found by submitting a permit for the BGT when it is discovered.

In this specific case, there was a BGT permitted but no BGT is onsite currently or historically. Prior OCD inspections did not indicate the presence of a BGT as stated by Jonathan Kelly (NMOCD). This location currently has an open top steel AGT. HEC has reviewed our records and have discovered no BGT at this location. A review of Google Earth Maps history of this location (attached) does not show a BGT either.

HEC would like to request Closure of INC# 20210104.JK.1 and BGT Permit based on the fact that a BGT never existed at this location and the permit was submitted by clerical error.
