Circulate 1.5 bbls of cement to surface. Plug down at 11:00 am. WOC. NU BOP. Pressure test BOP to 250#, low - 15 minutes and to 2000#, high - 15 minutes - ok. Test 9.625" casing to 750# - 30 minutes - ok.**
