8/3/11 Completion rig moved in. Pressure tested casing to 2000# - ok. Run CBL from 7920' to 3000' TOC @ 3400'.

Perforate the Dakota as follows: 7732'-38', 7752'-58', 7834'-40', 7860'-72' (3 spf, 90 holes).
Performed two stage frac job. First stage: frac with 158,646 gallons of ER-66 frac fluid with 160,500# OF 20/40 sand. TIH and set composite frac plug @ 5870'. TIH and perforate the Mesaverde as follows: 5710'-20', 5736'-40', 5750'-54', 5788'-94' (1 spf, 24 holes). Second stage: frac with 158,120 gallons of 13CP 70Q Delta-R-Foam frac fluid with 99,600# of 20/40 sand.

Clean out and flow back well. Drill out composite frac plug, clean out and circulate casing to new PBID at 7926'.

8/17/11 TIH with 2.375" 4.7# J-55 production tubing, set at 7828'.
