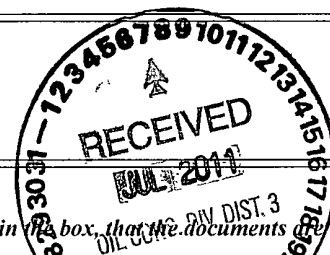

Please note that notifications may be made earlier to the district office should a greater release occur.
