8/6/11 Drill 8.75" hole to 4455'. Run 104 jts. 7" 23# J-55 LT&C casing, set at 4453'. Cement with 490 sks. Class G, PBR II, 5#/sk gillsonite, 1/4#/sk flocele tailed with 100 sks Class G, PBR II, 5#/sk gilsonite, 1/4#/sk flocele (1337.4 cf). Circulated 60 bbls of cement to surface. Plug down at 14:00 hours on 8/6/11. WOC. Tested BOP 250# low - 10 minutes and 2000# high - 10 minutes - ok. Tested 7" casing to 1500# - 30 minutes - ok.
