Plug down at 16:19 hours on 8/9/11. Circulate 10 bbls of cement to surface. WOC. NU BOP. Test BOP 250# low - 15 minutes and 2000# high - 15 minutes - ok. Test casing to 750 psi for 30 minutes - ok.
