8/28/11 Drill 8.75" hole to 5065'. Run 7" 23# J-55 LT&C casing, set at 5064'. Cement first stage with 28 sks. 12.3# PRB-II, 5#/sk gilsonite, 1/8#/sk flocele and tail with 102 sks 13.5# PRB-II. (66 cf.) Bump plug 400#, pressured to 900#, relieve psi - float held. Pressured to 2200#, open DV tool, did not circulate cement to surface. Circulated 4 hours between stages. Cement second stage with 500 sks 12.3# PRB-II and tail with 30 sks 13.5# PRB-II, 5#/sk gilsonite, 1/8#/sk flocele (185 cf). Bump plug with 675#, close DV tool with 2476#, relieve psi - flowed back 1.5 bbls. Did not circulate cement to surface. WOC. Due to heavy rains and bad road conditions, unable to get to location to run Temperature Survey or CHL within 12 hours.

Notified Brandon Powell (OOD) and Wayne Townsend (BLM).

Tested BOP 2000# high - 15 minutes and 250# low - 15 minutes - ok. Pressure tested 7" casing at 1500# for 30 minutes - ok. TOC will be determined at time of completion.
