Cement with 450 sks PRB-II, 5#/sk gilsonite, 1/8#/sk poly-e-flake, .3% FE-2, .3% D-air 3000 tailed by 150 sks 50/50 Poz, 5#/sk gilsonite, 1/8#/sk poly-e-flake, .2% CFR-3 without defoamer (1257 cf). Plug down at 24:00 hrs on 7/20/11. Circulated 42 bbls of cement to surface. WOC. NU BOP. Test BOP to 250#, low - 15 minutes and to 2000#, high - 15 minutes - ok. Pressure test casing to 750# for 30 minutes - ok.
