This well was first delivered on 7/27/2011 and produced natural gas and entrained hydrocarbons.

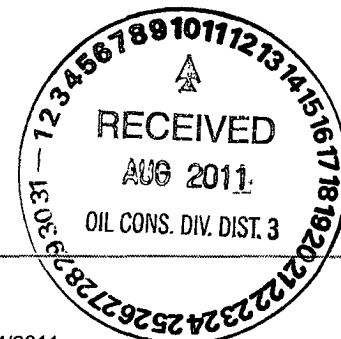
