1. Energen will annually update the status of the 80 acre infill and will submit a subsequent report requesting a continued status of TA, or if a change of status is needed to produce (i.e. 80 acre infill approved) or to plug and abandon the well, Energen will submit a NOI.
2. The casing pressure test is good for five years, at which point, if the well is still not activated, another casing MIT will be performed on the well.

Based on the above conditions:

Energen requests that the TA status continue on the wellbore one more year pending 80 acre FRC study/committee results. (through 10/26/12)
